# **Key findings**

During the summer 2012 exam series, over 2.4 million GCE A level (AS and A level) certifications were made. More than 5.9 million GCSE qualifications were awarded in England, Wales and Northern Ireland during the summer 2012 series.

Following the release of results from summer 2012, there was a total of 279,046 enquiries about results across all three service types<sup>1</sup> compared with 204,575 in 2011, representing an increase of 36 per cent. This is in the context of over 21 million unit entries for exams and internal assessments in 2012: a 15 per cent increase compared with 2011. All completed enquiries received in 2012, have been processed within deadlines. Fifteen are still being processed but are currently within the deadlines set out in the GCSE, A level, Principal Learning and Project Code of Practice<sup>2</sup>

Centres should request a review of marking where they have concerns about the accuracy of the initial marking of candidate work. Of the 14.4 million GCSE and A level exam scripts that were marked, 275,808 enquiries were made for a service 1 re-check or a service 2 re-mark. Service 1 and Service 2 are for external assessments marked by the awarding organisations. This represented 1.92 per cent of scripts. This percentage has increased from 1.34 per cent in 2011 and has shown a steady increase over the last five years. In 2008 it was 0.91 per cent.

In the majority of cases, enquiries about results did not reveal inaccurate marking that required a change to candidates' initial grades. The overall total of qualification grade changes resulting from all three services in summer 2012 was 45,630 (0.54 per cent of all subject certifications), an increase of 18.7 per cent compared with 2011.

For GCSE and A level there has been an increase in the number of enquiries submitted and the number of resulting grade changes during the period 2008–12.

The period 2009–12 has seen some significant revision to the structure of GCSE and A level qualifications, with a move from six to four units in many A level subjects and the introduction of the A\* grade at A level. The majority of GCSEs are now unitised, which has led to an increase in the number of individual unit entries made, and

includes a new form of internally assessed controlled assessment. These changes will have impacted on the number of enquiries about results received and the resulting grade changes. Therefore, they are a factor in changes seen over this period.

## Introduction

This statistical bulletin, published on behalf of the regulators in England, Wales and Northern Ireland, presents data on enquiries about results made to awarding organisations for the summer 2012 GCSE and A level exam series. The report summarises the performance of the six awarding organisations offering these qualifications in England, Wales and Northern Ireland:

- Assessment and Qualifications Alliance (AQA)
- Council for the Curriculum, Examinations and Assessment (Northern Ireland)
   (CCEA)
- Edexcel
- International Curriculum & Assessment Agency Examinations ICAA(E)
- Oxford Cambridge and RSA Examinations (OCR)
- WJEC.

The awarding organisations provide the regulators – Ofqual, the Welsh Government and the Council for the Curriculum, Examinations and Assessment (CCEA) – with statistical data on enquiries about results.

#### The report:

- details the processes and 2012 reporting arrangements for enquiries about results
- provides data on the six awarding organisations in terms of the three common services for enquiries about results
- provides data on the number of enquiries received, the number of resulting qualification grade changes and the performance of each awarding organisation in meeting deadlines
- provides data on the units with the highest percentage of enquiries as a proportion of entries.

A report presenting the final data on appeals for the summer 2012 exam series will be published in March 2013.

Once published, data may be revised in subsequent bulletins due to late-received data or if an error is identified. In this bulletin some figures have therefore been revised since last year's report.

## The enquiries about results process

Every year, the GCSE and A level awarding organisations publish information and guidance for schools and colleges on making use of the post-results service for the relevant summer exam series.

Candidates receive the results of their summer exams in August. If a school or college is concerned about the accuracy of a candidate's result, it can ask the awarding organisation to investigate the marking. Candidates cannot ask awarding organisations to investigate; they must ask through their school or college. This is because the school or college have responsibility for entering candidates for exams. Private candidates are an exception; they can ask the awarding organisations directly.

If the investigation shows marking or processing errors have been made and the candidate's result is incorrect, the awarding organisation will adjust the mark to the correct level. In some cases this may affect the overall qualification grade, which will then also be adjusted. Since 2001, grades have been adjusted downwards as well as upwards.

Each awarding organisation offers three post-results services for reviewing and checking exam scripts and internal assessment<sup>3</sup>. These are common to all awarding organisations, and comprise:

- service 1: a clerical re-check for an individual candidate
- service 2: a post-results review of marking for an individual candidate
- service 3: a re-moderation of the school's or college's internal assessment using a sample of candidates.

#### Service 1: clerical re-check for an individual candidate

The awarding organisation checks the script to make sure every question has been marked and the total number of marks awarded for each paper is correctly added up and recorded. It provides a statement of the marks awarded for each part of the exam for the candidate. Schools and colleges must request this service by 20th September. The deadline by which awarding organisations must notify centres about the outcomes of enquiries about results for service 1 is 20 calendar days from the date of receipt.

#### Service 2: post-results review of marking for an individual candidate

A second examiner (wherever possible, marking should be undertaken by someone other than the original examiner) reviews the marking of the original examiner to make sure the authorised mark scheme has been applied appropriately. This process may also be called a re-mark. The awarding organisation also does a full clerical re-check (service 1).

There are two levels of priority for service 2:

- non-priority schools and colleges must request this by 20th September
- priority schools and colleges can request this if the candidate's place at further or higher education depends upon the outcome of an enquiry about results. Requests for a priority-level service 2 enquiry must be submitted within eight calendar days of the result being issued.

The deadline by which awarding organisations must notify schools and colleges about the outcomes of enquiries about results for service 2 is 30 calendar days for the non-priority service and 18 calendar days for the priority service from the date of receipt.

# Service 3: re-moderation of the school's or college's internal assessment using the sample of candidates

Service 3 is not available for individual candidates, as the re-moderation must be undertaken on the sample of candidates' work used in the initial moderation.

The awarding organisation re-moderates a school's or college's internal assessment marks and provides feedback on their assessment of the candidates' work. This service must be requested by 20th September. The deadline by which awarding organisations must notify schools and colleges about the outcomes of enquiries about results for service 3 is 40 calendar days from the date of receipt.

## Summer 2012 exam series





Figure 1: Total entries for GCSE and A level, summer exam series, 2008–12

In the summer 2012 exam series, over 2.4 million A level (AS and A level) results were issued. More than 5.9 million GCSE qualification results were issued in England, Wales and Northern Ireland during the summer 2012 series. There were 15.7 million GCSE unit entries, an increase of 22 per cent from 2011. There were 5.5 million A level unit entries, which represent a 1 per cent decrease on the previous year (see Table 1 and Figure 1).

There were 14.4 million GCSE and A level exam scripts marked in the summer 2012 exam series; 275,808 enquiries were made for a service 1 re-check or a service 2 re-mark. This represented 1.92 per cent of scripts. This proportion has increased from 1.34 per cent in 2011 and 0.91 per cent in 2008, continuing the trend of a steady increase over the last five years (see Table 2 and Figure 2). Although the number of scripts has decreased over the last five years, the number of service 1 and 2 enquiries has continually increased (see Table 2)

The period 2009–12 has seen some significant revision to the structure of GCSE and A level qualifications, with a move from six to four units in many A level subjects and the introduction of the A\*grade at A level. The majority of GCSEs are now unitised, which has led to an increase in unit entries, and include a new form of internally assessed controlled assessment. These changes will have impacted on the number of enquiries about results received and the resulting grade changes. Therefore, they are a factor in changes seen from one year to the next.

Following the summer 2012 exam series, enquiries about results were received for the following services:


## **Qualification grade changes**

For A level, across all three services, there was a total of 14,120 qualification grade changes following an enquiry, representing 0.57 per cent of all A level subject certifications. This was an increase from 0.48 per cent from the previous year; this increase is statistically significant (see Table 3 and Figure 3).

For GCSE, across the three services, there was a total of 31,510 qualification grade changes following an enquiry, representing 0.53 per cent of all GCSE subject certifications. This was an increase from 0.45 per cent from the previous year; this increase is statistically significant (see Table 3 and Figure 3).

For both GCSE and A level, there has been a steady increase in the percentage of enquiries that result in qualification grade changes over the last five years. However, the rate of increase has been slower than the increase in the number of enquiries made by schools and colleges.

**Figure 3:** Qualification grade changes resulting from an enquiry as a percentage of total subject certifications, summer exam series, 2008–12




#### Service 1: clerical re-check

(See Table 4 and Figure 4.)

For GCSE results, there were 1,527 enquiries, an increase of 14 per cent from the previous year. All these enquiries were completed within the deadline. Of these enquiries, 37 resulted in a change to the overall qualification grade, a decrease of 18 per cent from 2011. This represents less than 0.01 per cent of all GCSE qualification certifications. Over the last five years, while the number of enquiries received by awarding organisations has remained relatively consistent, there has been a downward trend in the number of qualification grade changes.

For A level results, there were 646 enquiries, an increase of 16 per cent from the previous year. All these enquiries were completed within the deadline. Of these enquiries, 21 resulted in a change to the overall qualification grade, an increase of 50 per cent from 2011. This represents less than 0.01 per cent of all A level qualification certifications.

#### **Service 2: non-priority re-mark**






Figure 5: Service 2 non-priority re-mark enquiries, summer exam series, 2008–12

(See Table 5 and Figure 5.)

For GCSE results, there were 183,838 enquiries, an increase of 49 per cent from the previous year. This is the context of a 22 per cent increase in the number of individual unit entries made for GCSE. All completed enquiries have been processed within the deadline. Two are still being processed, but are currently within deadlines.

Of these enquiries, 25,117 resulted in a change to the overall qualification grade, an increase of 24 per cent from 2011. This represents 0.42 per cent of all GCSE qualification certifications.

For A level results, there were 69,152 enquiries, an increase of 20 per cent from the previous year. Unit entries remained fairly consistent for A level, with a 1 per cent decrease. All completed enquiries were processed within the deadline. Five are still being processed, but are currently within deadlines.

Of these enquiries, 10,154 resulted in a change to the overall qualification grade, an increase of 23 per cent from 2011. This represents 0.41 per cent of all A level qualification certifications.

## Service 2: priority re-mark

(See Table 6 and Figure 6.)

For A level results, there were 20,645 priority enquiries, an increase of 9 per cent from the previous year. All these enquiries were completed within the deadline. Of these enquiries, there were 2,788 qualification grade changes, an increase of 4 per cent from 2011. This represents 0.11 per cent of all A level qualification certifications. As Figure 6 illustrates, there has been a year-on-year increase in the number of priority enquiries received by awarding organisations and the resulting qualification grade changes.






#### Service 3: re-moderation of internal assessment

(See Table 7 and Figure 7.)

These enquiries each apply to a number of candidates within a school or college, not individual candidates, as awarding organisations moderate a sample of candidates' work to check the schools/colleges marking (samples consist of several candidates' work). Remoderation may, therefore, result in grade changes for more than one candidate as the result of a single enquiry from their school or college.

For GCSE results, there were 1,991 enquiries, an increase of 11 per cent from the previous year. All completed enquiries were processed within the deadline. Eight are still being processed but are currently within deadlines. As a result of these enquiries, 6,356 qualification grades were changed, an increase of 8 per cent from 2011. This represents 0.11 per cent of all GCSE qualification certifications.

For A level results, there were 1,247 enquiries, a decrease of 4 per cent from the previous year. All of these enquiries were completed within the deadline. As a result of these enquiries, 1,157 qualification grades were changed, a decrease of 11 per cent from 2011. This represents 0.05 per cent of all A level qualification certifications.



GCSE enquiries can be either at subject or unit level depending on the specification concerned.

Figure 7: Service 3 enquiries for summer exam series, 2008–12


### Unit level grade changes for A level


All A level qualifications have been unitised since 2000. For unitised qualifications, an enquiry about results (EAR) is requested per unit outcome, rather than for the overall qualification outcome. Any grade change at unit level may or may not lead to a grade change at overall qualification level, dependent on the extent of the unit mark change and a candidate's initial proximity to overall subject grade boundaries. Where a candidate has been allocated a mark just above or below a unit grade boundary, a change of a small proportion of marks as a result of a review of marking may lead to a change of unit grade. Depending on the scale of this change, it may result in a change to a candidate's overall qualification outcome.

Centres can request a review of marking where they have concerns about the accuracy of the initial marking of candidate work. For summer 2012 exams, enquiries about results were requested for 2.2 per cent of all marked scripts for A level. The majority of enquiries about the marking of A level examined units did not find inaccurate marking leading to a change in unit grade.

For all awarding organisations combined, at A level, 20.32 per cent of the 90,443 service 1 and 2 enquiries received against an examined unit outcome resulted in a change to the unit grade. This is down slightly on last year when it was 20.48 per cent and continues the downward trend over the last five years. In 2008 it was 22.27 per cent (see Figure 3).

In total, 18,378 unit grades changed following re-marking, with 15,745 increasing and 2,633 decreasing. This resulted in 12,963 qualification grade changes of which 12,606 moved up and 357 moved down (See Table 9). Although the number of enquiries has been increasing, the number of resulting grade changes as a proportion of enquiries received has been decreasing (see Table 8 on p.00 and Figure 8).





# Average response time

(See Table 10)

The GCSE, A level, Principal Learning and Project Code of Practice<sup>4</sup> sets out the maximum timescales by which awarding organisations should complete enquiries submitted by centres and report the outcome.

Awarding organisations have 20 calendar days to complete service 1 enquiries, 30 calendar days for service 2 (non-priority) and 40 calendar days for service 3. The deadline for priority service 2 is 18 calendar days and only applies to A level.

All completed enquiries about results have been processed within deadlines set in the GCSE, A level, Principal Learning and Project Code of Practice. Fifteen are still being processed, and although they have not yet been finalised, they are still currently within deadlines.

In the majority of cases enquiries were completed well within the maximum time allowed. The trend across awarding organisations is that the average time taken to complete enquiries is steadily decreasing over time. This reduction in the average completion time, and the difference in average completion times across the awarding organisations, is likely to be affected by the proportion of scripts that each awarding organisation scans and marks on-screen each year, compared with the proportion marked on hard copy. The volume of enquiries received, efficiency of systems and resourcing of the enquiries process will also be factors.

# **Unit / subject information**

(See Tables 11 and 12)

Centres can submit enquiries about results where they believe the initial marking of candidates' assessments may have been inaccurate.

Each year, particular subjects and exams receive a higher proportion of enquiries than the majority of subjects and units. For most units, requests for re-marking from centres are received for only a small proportion of the total candidates taking that unit. Very few units receive enquiries for more than 5 per cent of the candidates who took the unit.

Tables 11 and 12 list the five exams of each awarding organisation in summer 2012 that received the highest proportion of enquiries for service 2 and priority service 2. Exams for particular subject areas appear more frequently in this list than others, with English, modern foreign language and history exams appearing for almost all awarding organisations. Mathematics and science exams appear far less frequently due to them receiving a lower proportion of requests for re-marking of candidate scripts. This will be due, in part, to the differing nature of subjects, the type of assessment and the differing type of responses expected from candidates.
